


Bids were opened for the above referenced project on Wednesday, July 29, 2020 at 10:00 a.m. at Double Oak Town Hall. Six (6) bids were received for the project. Halff Associates has verified the bid tabulations and the overall low bidder is **Peachtree Construction**. Please see a summary of the Timberleaf Drive bids below. The low bidder and bid amount are highlighted.

Peachtree Construction's bid bonds, qualifications, and experience are attached to this letter. Peachtree listed the following referenced projects:

- 1. Town of Prosper Prosper Trail from Coit Road to Custer Road. This was a base repair and overlay in October 2018 in the amount of \$81,611.00
- 2. City of Keller 2014 Residential Reconstruction Project. Asphalt reconstruction in January 2016 for \$938,048.00.
- 3. City of Bedford 2019 Street Mill & Overlay. This was a 2" mill and overlay project in October 2019 in the amount of \$782,445.87.

In 2010 Peachtree Construction did an asphalt overlay for Knob Hill Drive, Creekside Drive, Oakview Drive and Rancho Vista for the Town of Double Oak.





Halff recommends awarding the Timberleaf Drive mill and overlay project to **Peachtree Construction, Ltd.** in the amount of \$57,520.00.

Re: Employee Benefits Renewal and Recommendation

Dear Ms. Kennedy:

The renewals have been received for medical, dental, life and disability for the October 1, 2020 renewal cycle. The renewal rates for the benefits provided by the Town of Double Oak are mostly unchanged.

The medical renewal presented by TML represents an increase of 5% or \$6,617 annually, if the Town elects to renew with TML a "re-rate" credit will be applied in the amount of \$6,224 divided evenly over 12 months. Once the re-rate credit is applied the net increase is \$393 annually. The TML pool has run well over the past 12 months which has produced this re-rate credit 2 years in a row. TML is the best option for the Town.

Principal currently provides dental coverage to the Town and they have provided a renewal with a 0% increase, however Dental Select has offered a plan that reduces the cost to the Town by \$1731 annually. My recommendation is to transition to Dental Select.

MetLife currently provides life, STD and LTD coverage and they have requested an increase of \$405 annually increasing cost from \$5,035 to \$5440. Because of the percentage of first responders we were unable to secure a more competitive option for the Town.

The overall cost to the Town for all benefits provided represent an overall reduction in cost of \$933 annually.
