JUSTIFICATION

item 11 adjusts item quantity based on one additional actually removed and two more anticipated.

Item 18 add additional driveway for resident who planned on constructing circular driveway since before construction.

Item 22 additional quantity due to sidewalk adjustment for mailbox and new driveway.

Item 55 provides payment for additional pipe used to avoid conflict with utility.

Item 55 reduces 48 IN RCP due to 36 IN RCP being utilized to avoid utility conflict.

CO1-A provides payment for collar at transition between the 36 IN and 48 IN RCP

CO1-B provides payment for restocking fees associated with the unused 48 IN RCP as well as transprotation fees associated with hauling the 36 IN and 48 IN RCP.

CO1-C provides payment for obtaining and installing two 45 Degree bends on SD LAT A-7 to avoid utility conflict.

Road and Drainage Committee Actions and Interactions (DRAFT 4, 11/14/22)

Year-Round: Any issues regarding drainage, potholes, signage, etc. that are brought to the attention of committee members are referred to the Public Works Director (PWD). For drainage issues, the PWD typically requests an engineering study.

NOTE: Double Oak is financially responsible for drainage that is under the road. Homeowners are responsible for maintaining drainage in bar ditches per Double Oak Town Ordinance. Other drainage issues identified by the town or residents managed on a case-by-case basis.

Annually

Jan-Mar: Committee selects roads to evaluate for reconstruction/overlay (approx. 3) and crack-sealing (15-20). Members then go out to examine and rate those roads. Committee meets to determine, from the individual ratings, the collective priorities of the roads. Chairman prepares "Proposal to Town Council" containing 1> Proposal of roads to be reconstructed/overlayed including associated drainage issues for CURRENT FY, 2> Proposal for roads to be pre-approved for crack-sealing in the NEXT FY, and 3> other situations that should/could be addressed CURRENT FY.

<u>Mar-Apr</u>: Town Council (TC) then may authorize PWD to go out for bids for some/all of the proposed projects. After bids have been received, TC approves the projects it wishes to fund.

<u>Apr-Sept</u>: Mayor signs bids. PWD supplies authorized bids to selected contractors, tracks progress on work, and updates TC, R&D committee, and residents as work is scheduled and completed. Projects for CURRENT FY are completed.

Oct-Dec: Review completed projects from previous FY and update road and Five-Year-Plan data.
