Mayor Pro-Tem Patrick Johnson was absent. Also in attendance were Town Secretary Eileen Kennedy, Public Services Randall Anglin, and Police Chief Ruben Rivas, and Town Attorney David Berman.

Mayor Donnelly called the meeting to order at 7:00 p.m.

IV. Mayor, Council Members and Staff reports:

3. Mayor and Council —Council Member Hillyer commented that if council is using their personal devices to check town emails and contract some sort of malware, Datamax will not support, and you will be on your own to get the problem resolved.

4. Public Works - Code Enforcement - Animal Control

Public Services Randall Anglin gave an update on the IT/Server room.

- 5. Administration Town Secretary Eileen Kennedy announced that Town Hall will be a voting site for the November 8 General Election.
- 6. Public Safety DOVFD, on the agenda. Police Chief Ruben Rivas reported that two applicants will start on November 21, received the body cams but waiting on the server that will not be delivered until February 2023. Chief Rivas commented that Brian Shults is helping with the laptops in the police vehicles and he is very appreciative of Brian's help. 12. Discussion, consideration, and action on a contract for fire protection services between the Town and DOVFD.

Council Member and Fire Chief Scott Whisenhunt said he had signed an affidavit of conflict of interest and left the meeting at 7:31 p.m.

Brandon Miller, 155 E. Kings Road, spoke on what it means to be a Double Oak Volunteer Firefighter. Mr. Miller stated he is very proud to be a Double Oak Firefighter especially with one that has a great reputation.

Kathy Heimerdinger, 150 Brown Cliff Ct., spoke on behalf of the Double Oak Volunteer Fire Department Board of Directors. Ms. Heimerdinger asked the council to approve the updated contract as presented by Chief Whisenhunt.

Bonnie Morrow, 105 N. Forest, addressed the council stating she has never observed anyone at a town function to be excessively under the influence of alcohol.

Deputy Mayor Pro Tem Schoenrade began the discussion with the three proposed versions of the contract. Town Attorney David Berman explained the differences between version one and version two of the contract. Version one prohibits the use and consumption of alcohol beverages and illegal drugs on the premises and version two does not prohibit. Version three is an updated version of the original 2009 contract with two additions or corrections, the annual dollar amount the town pays the fire

department and adds that the town shall provide or reimburse the fire department for insurance coverage for all department owned vehicles and worker's compensation.

Motion Hillyer seconded by Parsons to approve version three of the Double Oak Volunteer Fire Department contract and authorize the mayor to sign.
